1. **To Receive Apologies and Approve Reasons for Absence.** Cllr Brown NCC
2. **To Invite Declarations of Interest.** None.

4. **Public Participation.** None.
- 5 **To confirm and sign minutes of the meeting held on 5<sup>th</sup> March 2018. Resolved.** Minutes were accepted as a true record. Chairman duly signed minutes and agenda.
6. **MATTERS ARISING FROM THE MINUTES;**
7. **To co-opt new Councillors.** No candidates.
8. **REPORTS**
  1. **Lighting.** Aylesbury mains had been asked again to give a presentation on low energy lights.
  2. **Roads and pavements.** Church lane had been visited by radio Northampton and highlighted as an example of how bad roads in the area had become. Road subsidence on the Bugbrooke Rd near the village signs had been reported.
  3. **The Green and Play Area.** All outstanding work on swings and furniture in the Play Area has now been carried out.
  4. **Playing Fields.** It was reported that the hedge and debris had been removed and that Chay Adams had removed the rubbish left over from the allotments. The Chair thanked him for this.
  5. **Trees.** A tree that had fallen over the river had been reported and had been cut up and removed.
  6. **Allotments.** There had been a successful first meeting of allotmenters. Mr Corner had volunteered to cut grass paths. Clerk to check on insurance implications of this. The unused allotments have been ploughed, and may be grassed. SC was hoping to find volunteers, or the Community Engagement gangs or similar, to do work on the allotments
  7. **Footpaths.** No report.
  8. **Churchyard.** Clerk had sought quotes for pollarding the Limes, but it was now felt that this would have to wait till later in the year. Meetings about the use of the churchyard for ashes had been deferred.
  9. **Canal.** MB reported that the Trust would be carrying out remedial works shortly.
  10. **Joint Burial Board.** A Meeting had been held on March 26<sup>th</sup>. Work to be done on the Yews.
  11. **Youth Club.** LE thanked LD for all her work on the Youth Club.

10.	<b>GDPR – Resolved.</b> Danny Moody of Ncalc to be appointed as Data Protection Officer. This would initially be a free service. It was not yet clear whether a clerk could be a DPO.
11.	<b>Finger Posts – deferred.</b> The situation at NCC made it unlikely that they could help.
12.	<b>Adoption of Bliss Close lighting. – Resolved.</b> Council to adopt the lights on Bliss Close.
13.	<b>Neighbourhood Plan – SC reported that 117 visitors had attended the presentations. After a meeting with SNC the Neighbourhood Plan group had decided that it would be in their best interests to select preferred sites for development. It had previously been felt unnecessary.</b>
14.	<b>Lights on the Green, and Furnace Lane – deferred until a meeting with Aylesbury mains could be arranged.</b>
15.	<b>Audit – Reports.</b> Clerk had had contact with both external and internal auditors. The internal audit would have to be done prior to the next meeting, which gave a much tighter schedule than had previously been the case.
16.	<b>Litter Picking Equipment. – to consider purchase.</b> The Youth Club felt that there might be storage space available. Clerk to look into purchasing high Visibility Jackets, litter pickers, gloves and bags.
17.	<b>Social Media – adverse comments concerning Council.</b> LD and A-M. C volunteered to run an experimental Facebook page. There was concern that this could become an onerous task, and that it was best to only present
